Call to Order

- 1. Consideration to approve a grant from the Cape Elizabeth Education Foundation (CEEF) in the amount of \$22,000.** *[per SB policy, KCD: Public Gifts/Donations to the School]*

Applicant(s): Lance Belanger (PE Teacher) - **CE Middle School** - \$22,000 - **Workout on Wheels** - Approved June 1, 2022.

The Workout on Wheels project will incorporate physical activity during Physical Education classes that will include the lifetime activity of Biking.

Students will be equipped with all of the necessary protective and hygienic gear to ensure safe participation. Students will be instructed on the foundational motor and safety skills associated with the activity, and will practice appropriate etiquette and personal responsibility. One goal of the project is designed to offer students new and different physical activity options to enhance their value of

physical activity and to meet the goal of creating a differentiated Physical Education Curriculum at the Middle School level. This project will help us make progress in diversifying the grades 7 & 8 curriculum.

For short term goals, we want to provide students learning opportunities that will introduce them to basic biking skills, group riding skills on roads/trails, and biking safety. This will allow students to increase their confidence on a bike, and to practice different learning experiences, expand their physical activity exploration, and better prepare them for High School Physical Education and beyond.

The long-term goals are primarily focused on providing students with diverse options of physical activity exploration that have a high lifetime carryover value. Another long-term goal is to continue to build a quality Physical Education program that reinforces inclusion and expanding avenues for students to uncover and increase value in participating in lifelong physical activity.

These expanded activity options will help meet the goal of providing multiple pathways for student academic achievement and meeting the needs of 21st century learning. Our final long-term goal is to build physically literate students. This encompasses the process of students developing the skills, knowledge, and confidence to be physically active for life.
