COVID-19 Update

In response to the recent outbreak of Coronavirus Disease 2019 (COVID-19) the Governor signed LD 2167, An Act To Implement Provisions Necessary to the Health, Welfare and Safety of the Citizens of Maine in Response to the COVID-19 Public Health Emergency, which is now PL 2019, c. 617.

Part G enacts Title 1, section 403-A, Public proceedings through remote access during declaration of state of emergency due to COVID-19. It authorizes conducting public proceedings through telephonic, video, electronic or other similar means of remote participation with specific conditions. The section is repealed 30 days after the termination of the state of emergency.

1. 1. Town Council and School Board Review of the FY 2020 Audit Results

The Town Council and School Board will meet in workshop session to receive the results of the fiscal year 2020 audit from Runyon Kersteen Ouellette.

2. 2. Presentation from Stephen Harding Relating to the Access Relocation at Kettle Cove and Crescent Beach for the Purpose of a Marine Launch

Opportunity for Public Comment (Limited to 15 minutes; 3 minutes per person. Time may be extended by a majority of the town council.) Persons wishing to address the council shall indicate their desire using the Raise Hand function of the Zoom meeting. When recognized by the chairman, the speaker shall give his or her name and address or local affiliation, if the affiliation is pertinent.

Through the ad-hoc Harbors Committee a comprehensive review of issues related to Cape Elizabeth's shoreline and harbors was conducted.

One of the recommendations of the Harbors Committee Report dated 4/30/2018 was to: Resolve Kettle Cove/Crescent Beach area access and circulation issues and implement other related changes (Section 4.4, Page 15).

A memo has been provided by Stephen Harding, Town Engineer summarizing a public meeting on January 14 and a revised preliminary plan depicting the proposed watercraft launch which is proposed to replace the nearby existing town launch.

Participation at Meetings and Conduct of Meetings

Workshop Meetings

The purpose of a workshop meeting is primarily for council dialogue involving reports

and proposals from council members, committees and staff that may be considered at later Town Council meetings. The Town Council may give guidance to the chairman and to staff at workshop meetings but no decisions may be made that require formal votes. Notwithstanding the prior sentence, the Town Council may vote on procedural motions at a workshop meeting to determine a conflict of interest, to enter into executive session and to adjourn. Prior to Town Council discussion on any item, members of the public may speak on each agenda item for not more than three minutes each and up to a total of 15 minutes. If there are more speakers than the time available, the chairman may allocate the speaking time in order to balance the debate. The public participation portion shall conclude when the Town Council begins its discussions.

Decorum

Persons present at Council meetings shall not applaud or otherwise express approval or disapproval of any statements made or actions taken at such meeting. Persons at Council meetings may only address the Town Council after being recognized by the chairman.
